### Speakers:

**Mr George Leung (梁兆基), Adviser, Strategy and Economics, Asia Pacific, Hong Kong and Shanghai Banking Corporation Limited, The HSBC Group**

George is responsible for the Bank's overall business strategy development and economic affairs for the Asia Pacific region. He also oversees the operations of the Bank's Area Management in Hong Kong. George joined the Bank in 1994 as Senior Economist. He became Economic Adviser and Head of Economic Research Department in 1996. He then took up the post of Chief Economist for the Greater China region in 2000, prior to his current appointment in 2006.

**Mr Gerry Ma (馬桂榕), Chairman, Small & Medium Enterprises (SME) Committee, Hong Kong General Chamber of Commerce (HKGCC)**

Gerry is also a committee member of the China Committee of the HKGCC, the SME Committee of HKSAR and the Public Libraries Advisory Committee of the Hong Kong Public Libraries. He is currently an adviser of The Cyberport Institute of Hong Kong of The University of Hong Kong

**Mr Shih Wing Ching (施永青), Chairman, Centaline Property Agency Limited**

Shih Wing Ching was born in Shanghai and brought up in Hong Kong. In 1978, Mr Shih established Centaline Property Agency Limited, involving in a great variety of businesses including property agency, surveying and valuation, personnel consulting services, wealth management, information technology development on property data and internet mapping services.
